

PokerGO Annual Subscriber Dream Seat™ Giveaway Official Rules

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. U.S. LAW GOVERNS. NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

PokerGO ("Sponsor") is pleased to introduce the PokerGO Annual Subscriber Dream Seat™ Giveaway ("Giveaway"). As a condition of participating in the Giveaway, you agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsor, whose decisions shall be final and binding in all respects, and, to the fullest extent provided by law, waive any right to claim ambiguity in the Giveaway, these Official Rules, Giveaway materials, and information contained on Sponsor's website, available at www.pgt.com/dream-seat. The Giveaway is subject to applicable federal, state, and local laws and regulations and is VOID WHERE PROHIBITED OR RESTRICTED BY LAW. Winning and receiving a prize is contingent upon fulfilling all requirements set forth herein.

1. SOCIAL NETWORKING SITE DISCLAIMERS

As a condition of participating in the Giveaway, you agree and acknowledge that social networking sites used to promote the Giveaway (e.g., Facebook, Twitter, Snapchat) as well as their owners, directors, officers, employees, contractors, agents, representatives, parents, subsidiaries, attorneys, insurers, and associated entities (collectively, the "Social Media Group") are not sponsors of the Giveaway, do not endorse or administer the Giveaway, and are not in any way associated with the Giveaway. All questions regarding the Giveaway must be directed to Sponsor, not the Social Media Group. 2. ELIGIBILITY

Each drawing will consist of entrants who have an Annual Subscription or have submitted an AMOE as of the applicable drawing date. Sponsor will randomly select one (1) winner from all eligible entrants to win the prize package stated above. Sponsor will also randomly select up to ten (10) alternates as replacement prize winners in the event the first winner is disqualified from the Giveaway or forfeits or otherwise waives their right to receive the prize. If an alternative is needed, Sponsor will randomly select a winner from the pool of ten (10) eligible alternates. Entrants acknowledge that the PGT is a filmed poker event.
